ARKANSAS STATE SENIOR MIXED TOURNAMENT

1. Members of Arkansas State USBC Association and Arkansas State USBC Women's Association who are 55 years of age or older are eligible to bowl. Spouses under 55 years of age may bowl on their teams but not qualify for awards.
2. Teams must be comprised of two men and two women.
3. Multiple participation is allowed in team event only, subject to Rules 315B. (At least two players in the line-up must be different in order to place more than once on the prize list.)
4. Use the highest book average for 2010-2011. New bowlers may use their current highest league average as of the last night they bowl prior to bowling the tournament. **This average must be verified by their league secretary.** Bowlers who have no previous average or current average may enter at 210 scratch. Rule 319A-2 (ten pin rule) will not apply. Rule 319D does not apply. **Rule 319E shall apply.**
5. Prize fund will be returned 100%. Prize ratio is one prize for each eight entries.
6. Entry fees must accompany all entries. After an entry has been received, and the dates assigned by tournament management are not refused before preparation of the schedule, the entry fee will not be refunded.
7. Handicap will be 80% of the difference between Team average and 840.
8. If a substitute is to be used, the substitute shall bowl in the same position as the absent bowler. Substitutions must be made at least 45 minutes prior to scheduled time of bowling.
9. Reservations will be on a first come basis.
10. Any rule not covered above, USBC rules will prevail.
11. SHIRTS AND BLOUSES MUST HAVE SLEEVES AND MUST NOT CONTAIN WORDS OR PICTURES DEEMED OFFENSIVE BY TOURNAMENT MANAGER. NO CUTOFF JEANS OR SPANDEX. DRESS CODE WILL BE ENFORCED.
